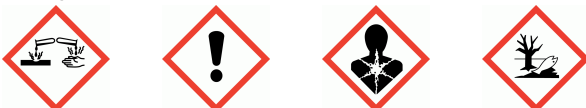

SECTION 4: First aid measures

4.1. Description of first aid measures

5.3. Advice for firefighters

Ventilate closed spaces before entering them. Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. 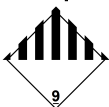
